Do your part to keep lowa's roads safe

Have you ever had to stop your vehicle on the side of a busy highway to check on a flat tire or a trailer

cover? Or maybe you've been pulled over by a police officer and worried about his or her safety on the shoulder of the road while hoping you can get away with just a warning!

If so, you are aware most drivers won't bother to move over or even slow

down as they pass by you. But as of July 1, Iowa's newly expanded move over or slow down law – Iowa Code section 321.323A – now requires motorists to move over or slow down when approaching ANY stationary vehicle with flashing lights activated, including passenger vehicles with hazard lights.

Those who disobey the law could receive a hefty fine or potentially lose their driver's license.

This law is particularly important to Access Energy Cooperative because it helps keep our lineworkers and maintenance workers safe as they often need to perform difficult and dangerous work with electric equipment on the road's shoulder. Even though our employees set out caution signs and orange cones, wear high visibility gear, and turn on their vehicles' emergency lights, other

motorists often fail to give them the room they need to do their job safely.

This law will help keep Iowa's roads safe for everyone – drivers, emergency responders, utility workers and others. But the law doesn't do much good if motorists don't know

about it. Please make sure to share this safety message with other drivers in your family, especially younger drivers who don't have as much experience behind the wheel. We can each do our part to keep Iowa's roads safe by simply moving over or slowing down (preferably both) when we see stopped vehicles on the side of the road. We encourage you to visit www.MoveOverIowa.com to sign a simple pledge in support of this law.

When you're behind the wheel, keep your eyes on the road and make room for utility workers and others who are stopped on the shoulder. Their jobs are dangerous enough already. *f*

Dividends are coming

Once a satisfactory level of margins or profits for 2017 was determined by the Access Energy Cooperative Board of Directors, the cooperative



assigned the rest of the margins to you – the members (each of whom owns a portion of the cooperative) – according to the amount of energy purchases you made in 2017.

Each member has a dividend account at the cooperative where your dividend allocations accumulate. When the board allocated the 2017 margins, your portion was moved to your dividend account. Notices were mailed May 31 with the amount that was allocated to your account.

This year, Access Energy Cooperative allocated \$1,637,496 and passed through allocations from Northeast Missouri Electric Power Cooperative (our power supplier) of \$1,074,508 for a total allocation of \$2,712,004.

The amount of total allocations the cooperative has stored in the dividend accounts was then reviewed by the Access Energy Cooperative Board of Directors to determine whether or not to generate a dividend payment this year. After reviewing the cooperative's current financial position, the board approved a dividend refund this year of \$1,085,593. This refund is 100 percent of the remaining dividends for 1997, 54 percent of 2003 and 10 percent of 2017.

Dividend checks will be available to pick up at the annual meeting on August 7. Any checks not picked up will be mailed after the annual meeting. Checks will be sent to the most current address we have on file. The cooperative won't print checks for amounts under \$5; these amounts will be added to next year's refund.


Practice safety with gasoline dispensing facilities near electrical equipment

One of the most common safety violations found near electricity lines is the location of the gasoline dispensing facilities on farmsteads, in relation to the meter pole or farm buildings.

The National Electrical Safety Code shows the requirements your farm wiring system should follow. One section of the wiring code covers the requirements for electrical equipment and wiring for all voltages in locations where fire or explosion hazards may exist due to flammable gases or vapors, flammable liquids and other volatile materials.

The National Electric Safety Code (NESC) outlines the standards that the

utility follows. Because of the hazard that exists in the vicinity of gasoline dispensing facilities, and especially the hazard to Access Energy Cooperative personnel wherever there's a possibility of electric sparks or arcing igniting flammable vapors, the NESC suggests that electric utilities not permit the installation of meter poles or service entrances within 20 feet of a gasoline dispensing barrel or tank, or within 3 feet of any point that could be reached by a gasoline dispensing nozzle. In addition, it's recommended that existing installations with less than the required clearances be modified to provide the required clearances.



For Access Energy Cooperative to change the location of existing meter poles would be quite costly. Therefore, we ask members to check to make sure their gasoline dispensing facilities are located 20 feet from the meter pole. The end of the dispensing nozzle should not be within 3 feet of the meter pole.

If Access Energy Cooperative discovers there's a violation of this requirement near our equipment, we have no choice but to disconnect the electric service at the site until the hazard is corrected.

In addition to these location requirements, please make sure your gasoline dispensing facilities are electrically bonded to the electrical ground of the farm wiring system. Install a ground rod at your gasoline tank and connect the tank to the ground rod and to the farm wiring ground. ***
